<b>2. Location</b>	Phuoc Thoi Ward, O Mon District, Can Tho City.
<b>3. Objective</b>	Investment in construction and trading of infrastructure of industrial zones
<b>4. Estimated scale of project</b>	Total area is 122 ha.

<b>7. Expected effect of project</b>	<p>Can Tho is the center of the Mekong Delta, with relatively good roads, waterways and airways; abundant human resources and improved quality. Many enterprises have demand for investment in manufacturing industries, especially seafood processing. These are the fields and areas of planning implemented in industrial zones. <p><b>8. Overview of the nature and status</b></p>	<p><b>Location:</b> Phuoc Thoi Ward, O Mon District, Can Tho City. In the Northeast, it borders on Hau River. In the southeast it borders Cai Chom canal and Tra Noc 2 industrial park. In the Northwest it borders on Noc canal. Southwest residential area and National Highway 91. 15km from the center of Can Tho city upstream, 8km from Can Tho port and airport.</p> <p>The project area has flat terrain, geological structure convenient for construction of industrial projects and services.</p> <p>The project area (including national highway 91, provincial road 920, Truong Van Dien street) conditions to ensure the infrastructure, especially electricity and water supply: the electricity supply is ensured from the national power grid O Mon power and thermal power plant; Having surface and underground water sources to meet the water use demands of the project; Communication in the project area has been built relatively smoothly for interconnection and international transactions.</p> <p>Traffic infrastructure connects directly to National Highway 91 and the main roads in the area, with the capacity of trucks weighing up to 30 tons.</p>
<p><b>9. Legal Foundation</b></p>	<p>To be added to the list of priority industrial parks to be set up by 2015 and orientated to 2020 by the Prime Minister (pursuant to Official Letter No. 2209 / TTg-KTN dated December 15, 2008).</p>

Investment Incentive Policy</b></p>	<ul style="list-style-type: none"> <li>• Be entitled to a 20% interest rate on loans for investment by credit institutions for loans in the term of the project. The maximum support for a project is 10 billion VND (subjected to Decision No. 07/2014 / QĐ-UBND dated September 5, 2014);</li> <li>• Exemption from land rental during the fundamental construction period, but not exceeding 03 years from the date of issuance of the land lease decision (provided by Clause 2, Article 19 of Decree No. 46/2014 / NĐ-CP dated May 15, 2014 issued by the government).</li> </ul>
